FURTHER, THROUGH THE FOUNDATION'S MODEL TRAINING CENTER, THE ONESKY EARLY LEARNING CENTER IN DA NANG, ONESKY PROVIDES DAILY CARE FOR 262 CHILDREN AGES 6 MONTHS TO 6 YEARS.
